ORDER

The instant order issues pursuant to the previous order of this Commission in the same matter of 2nd appeal of Shri Apratim Mukherjee Vs. West Bengal Financial Corporation dtd. 17.07.2012.

Shri Apratim Mukherjee, the Appellant, Sk. Sanjib Ahmed, Advocate on behalf of Shri Apratim Mukherjee and Shri Probal Dasgupta, General Manager & SPIO, West Bengal Financial Corporation are present .

Their verbal submissions are duly heard, perused and considered.

It is learnt from the appellant and the SPIO & General Manager, West Bengal Financial Corporation that Writ Petition No. 10405 (W) of 2012 filed by Shri Apratim Mukherjee before Hon'ble Justice Shri Dipankar Dutta of High Court, Calcutta is still pending awaiting final disposal.

The SPIO & General Manager, West Bengal Financial Corporation contends that the matter being still sub-judice, West Bengal Financial Corporation cannot part with the requested information in terms of the order of West Bengal Information Commission dtd. 29.10.2007 in the

matter of Shri Suneil Sarawgi Vs. West Bengal Financial Corporation in respect of Modern Refractories Pvt. Ltd., Purulia..

This Commission finds no reason to differ with the logic and contention of the General Manager & SPIO, West Bengal Financial Corporation. The Commission refrains from passing any order at this stage as the matter is sub-judice.

Hence, let the matter of the Writ Petition filed by Shri Apratim Mukherjee before Hon'ble High Court, Calcutta be decided and disposed of finally. The complaint of Shri Apratim Mukherjee will be heard on receipt of intimation as to final disposal of the Writ Petition.

The Case is thus adjourned sine-die.


